# 1. Summary

The National Transport Authority (the Authority) has statutory responsibility for securing the provision of public transport services as outlined in the Dublin Transport Authority Act 2008. The Act gives the Authority responsibility for setting public transport fares on contracted services. This fares determination sets out the fares for all the main Public Service Obligation (PSO) services namely bus, rail, Luas light rail, as well as bus services operated by Go Ahead Ireland in Dublin & Kildare; Waterford city services operated by Bus Éireann and all other tendered PSO bus services operated under contract to the Authority. Where reference is made to Dublin city bus or Bus Éireann in this document, it also includes Go Ahead Ireland.

The onset of the Covid-19 global pandemic in March 2020 resulted in a substantial reduction in fare revenues arising from significant decreases in the use of public transport. This was offset by significant additional government funding to ensure services could continue at pre-pandemic levels in line with public health restrictions. For this reason the Authority decided not to proceed with a fares determination in 2020, meaning that the vast majority of fares remain at 2018 prices.

In light of the continuation of the restrictions arising from the pandemic and the impact on passenger confidence, the Authority decided not to implement a full fares determination in 2021, opting to focus on making the small number of remaining adjustments necessary to support the roll out of BusConnects in Dublin. This has seen the implementation of a new fares structure for Leap and cash on Dublin city bus services and for Leap initially on rail and Luas light rail services in the Dublin area. The fare system comprises a short distance fare and a 90 minute fare. The 90 minute fare covers any journeys taken within 90 minutes of the start of the first leg of a journey. These journeys can be taken on Dublin city bus, Luas light rail, larnród Éireann DART services and zones 1 to 4 on Short Hop Zone (SHZ) commuter services, or any combination of these services within the Dublin area.

In its response to a sharp increase in price inflation across the economy in recent months, the government announced a package of measures on 10<sup>th</sup> February 2022 to mitigate the impacts of increasing cost of living expenses. Part of this package is to introduce a temporary reduction in fares on all PSO public transport services by an average of 20% until the end of 2022. The 20% reduction in fares will apply in addition to the previously announced introduction of Young Adult fares as part of Budget 2022, which will provide young people with an average 50% discount of equivalent adult fares. A timely and simultaneous implementation of both schemes across all PSO services entails significant complexity in relation to fares adjustments for both the Authority and Operators alike. For this reason the Authority intends for this to form the main focus of this year's fares determination, with other structural changes being deferred to future determinations.

It has, however, been possible to bring forward a number of other changes to fares structures for the benefit of passengers, including the introduction of Mallow to the commuter fares zone in Cork; a new flat bus fare for all children in regional cities in line with that introduced in Dublin; and proposals for Taxsaver products to incentivise a return to public transport for commuters in the year ahead.





A summary of the main changes are as follows:

#### Dublin's city bus services operated by Dublin Bus and Go Ahead Ireland

- The short adult Leap fare priced at €1.60 will be discounted to €1.30, enabling passengers to travel for less between 2km and 3km on all Dublin city bus services.
- The introduction of the 90 minute adult Leap fare allows passengers to travel extensively across the Dublin city bus network, with the added benefit of free onward transfer within 90 minutes of initial tag on. As outlined in November 2021, this fare will revert to the determined level of €2.50. However, the introduction of a 20% discount on all PSO fares means that this fare will be reduced to €2.00 in 2022, offering significant value for bus passengers.
- New Young Adult fares will be introduced on all Dublin city bus services on Leap only, comprising of single fares for short distance, 90 minute, Xpresso and Nitelink services. These are priced at approximately 50% of the equivalent adult fare. Additionally, these fares will also benefit from a 20% fares reduction in 2022, offering exceptionally good value for those passengers. The Young Adult Leap 90 minute fare will be €1.00 which offers very significant value to customers.
- The recently introduced flat child Leap fare which allows all children to travel anywhere on the Dublin city bus network with the additional benefit of a free transfer to any mode within 90 minutes of initial tag on, will be discounted from 80 cent to just 65 cent in 2022.
- All cash single fares (including Xpresso & Nitelink) and prepaid period products (e.g. Ramblers & Visitor tickets) will also be discounted by an average of 20%.
- Monthly and annual Dublin city bus products (including multi-Operator tickets incorporating Dublin city bus) will also be discounted by 20% in 2022, offering improved value for passengers who travel more frequently. These products may be purchased under the Taxsaver scheme, offering significant savings for commuters.

#### Luas light rail services operated by Transdev

- The short adult Leap fare priced at €1.60 will be discounted to €1.30, enabling passengers to travel for less between 2km and 3km on Luas services.
- The introduction of the 90 minute adult Leap fare allows passengers to travel extensively across the Luas network, with the added benefit of free onward transfer within 90 minutes of initial tag on. As outlined in November 2021, this fare will revert to the determined level of €2.50. However, the introduction of a 20% discount on all PSO fares means that this fare will be reduced to €2.00 in 2022, offering significant value for Luas passengers.
- New Young Adult fares will be introduced on all Luas services on Leap only, comprising of a single fare for short distance trips, and a 90 minute fare for longer and multi-leg trips. These are priced at approximately 50% of the equivalent adult fare. Additionally, these fares will also benefit from the 20% fares reduction in 2022, offering exceptionally good value for passengers. The Young Adult Leap 90 minute fare will be €1.00 which offers very significant value to customers.
- The recently introduced flat child Leap fare which allows all children to travel anywhere on the Luas network with the additional benefit of a free transfer to any mode within 90 minutes of initial tag on, will be discounted from 80 cent to just 65 cent in 2022.





- All cash single, return and prepaid period product fares (e.g. 1, 7 and 30 Day tickets) will remain as zonal tickets but will also be discounted by an average of 20%. All Luas add-on tickets will also benefit from the 20% fares reduction in 2022.
- Monthly and annual Luas products (including multi-Operator tickets incorporating Luas) will also be discounted by 20% in 2022, offering improved value for passengers who travel more frequently. These products may be purchased under the Taxsaver scheme, offering significant savings for commuters.

#### Rail Services operated by larnród Éireann

- The short adult Leap fare priced at €1.60 will be discounted to €1.30, enabling passengers to travel for less between 2km and 3km on all Dart and commuter rail services in the Dublin area.
- The introduction of the 90 minute adult Leap fare allows passengers to travel extensively on rail services within the Dublin SHZ, with the added benefit of free onward transfer within 90 minutes of initial tag on. As outlined in November 2021, this fare will revert to the determined level of €2.50. However, the introduction of a 20% discount on all PSO fares means that this fare will be reduced to €2.00 in 2022, offering significant value for rail passengers. The 90 minute fare will continue to apply within the 90 minute fare boundary (See Appendix M Dublin 90 minute fare boundary).
- Existing zones 5 & 6 journeys remain in the new Dublin fares structure for longer journeys, with associated fares also benefitting from the 20% fares reduction. Those choosing to purchase zones 5 or 6 single tickets on Leap will also be afforded free transfers within 90 minutes of initial tag on.
- For consistency across the SHZ in Dublin, journeys between Greystones and the city centre (Pearse, Tara & Connolly) will be adjusted from zone 6 to zone 5, providing savings for passengers.
- New Young Adult fares will be introduced on all rail services in Dublin on Leap only, comprising of single fares for short distance, 90 minute, zone 5 and zone 6 journeys. These are priced at approximately 50% of the equivalent adult fare. Additionally, these fares will also benefit from a 20% fares reduction in 2022, offering exceptionally good value for passengers. The Young Adult Leap 90 minute fare will be €1.00 which offers very significant value to customers.
- The recently introduced flat child Leap fare which allows all children to travel anywhere on rail services within the SHZ with the additional benefit of a free transfer to any mode within 90 minutes of initial tag on, will be discounted from 80 cent to just 65 cent in 2022.
- All cash single, return and prepaid period product fares (e.g. 1 & 7 Day tickets) will remain as zonal tickets but will also be discounted by an average of 20%.
- Monthly and annual rail products (including multi-Operator tickets incorporating rail) will also be discounted by 20% in 2022, offering improved value for passengers who travel more frequently. These products may be purchased under the Taxsaver scheme, offering significant savings for commuters.
- Mallow will be brought into the commuter rail fares area in Cork. This will see the addition of one new zone, with the introduction of Leap and cash fares to complement the existing ticket offering. This will mean that an adult may travel from Mallow to any station within the commuter area for just €3.90 when paying with Leap.
- Cork commuter passengers will also benefit from the introduction of Young Adult fares on Leap, and in addition, all fares will see a reduction of 20% in 2022.





Intercity passengers will see the introduction of Young Adult fares on all services, with singles, day
return and open returns being made available both from the booking office and for purchase online
in advance. All fares on Intercity services will also see the 20% fares reduction implemented for the
rest of the year.

#### Bus services outside Dublin operated in the main by Bus Éireann & Go Ahead Ireland

#### $\circ \quad \text{Regional cities} \quad$

- ✓ All city cash and Leap fares will benefit from the government's 20% cost of living fares reduction in 2022. This is inclusive of all singles, daily, weekly, monthly and annual tickets.
- ✓ New Young Adult fares will be introduced on Leap, offering 50% discount on equivalent adult Leap fares for both standard and outer zone journeys. These will also see a further 20% fares reduction in 2022, offering significant value for passengers.
- ✓ Child fares will be consolidated to become a flat child fare for all city journeys, including the retiral of the schoolchild fare on both cash and Leap. The new flat child Leap fare has been determined at 80 cent in line with Dublin and will be further reduced to 65 cent during 2022.

#### Town services

- ✓ All town cash and Leap single fares will benefit from the government's 20% cost of living fares reduction in 2022.
- ✓ New Young Adult fares will also be introduced on Leap, offering 50% discount on equivalent adult Leap fares for both standard and outer zone journeys. These will also see a further 20% fares reduction in 2022, offering significant value for passengers.
- ✓ Child fares will be also be consolidated to become a flat child fare for all town journeys, The new flat child Leap fare has been determined at 70 cent as journeys are typically less than that of city services and will be further reduced to 55 cent during 2022.

#### Stage Carriage

- All stage carriage single, day return and open return fares will see an average 20% discount in 2022 for all passengers.
- ✓ In addition, a new Young Adult single fare will apply on Leap, which will equate to 50% of the discounted adult fare, offering significant value for passengers.
- ✓ 10 Journey tickets cash will also be reduced by an average of 20% for all passengers.
- ✓ Regular commuters will also benefit from the 20% fares reduction on all monthly and annual point to point products, which offer very good value, particularly when purchased through the Taxsaver scheme.

#### Leap Capping

- ✓ All Leap caps in Dublin and Cork (daily and weekly for single and multi-Operator trips) will be reduced by 20% in line with the government's cost of living package.
- ✓ Young Adult caps will also be introduced at 50% of the discounted adult cap rate across all Operators.

All individual fares for each Operator can be found in the Appendices at the end of this report (**Appendices** - **Detailed Fare tables**).





# 2. Introduction

# 2.1 Background

The Authority has statutory responsibility for securing the provision of public transport services as outlined in the Dublin Transport Authority Act 2008. To fulfill this responsibility, the Authority entered into new public service contracts with Dublin Bus and Bus Éireann in December 2019 for a period of 5 years. The Authority has also entered into a contract with Go Ahead Ireland for the provision of bus services in the Outer Dublin Metropolitan Area (ODMA). Go Ahead Ireland also operate a number of Dublin Commuter services from Kildare, which were previously operated by Bus Éireann, following a tender competition. In Waterford city, Bus Éireann continue to operate city routes but from early 2019 these have operated under a new contract following a tender competition.

The Luas Operations and Maintenance contract was awarded jointly by the Authority and Transport Infrastructure Ireland (TII) to Transdev in 2019. The Authority has assigned the day-to-day management of the Luas contract to TII and fare revenues are retained by TII on behalf of the Authority.

The Authority also entered into a public service contract with larnród Éireann in December 2019 for a ten year period, as statutorily required.

All public transport contracts must, among other things, provide for "fares to be charged and provision for the variation, including increase or decrease, of fares". The Authority examines existing fares annually and determines the fares to be charged for the following year.

## 2.2 Determination of fares

This determination will cover the fares for Public Service Obligation (PSO) services provided by Dublin Bus, Go-Ahead Ireland (ODMA), Iarnród Éireann, Transdev, Bus Éireann, Bus Éireann (Waterford), Go Ahead Ireland (Dublin Commuter) and all other PSO bus service Operators providing services under contract to the Authority.

This determination will address the price of cash, Leap and pre-paid products including monthly and annual season tickets. As previously outlined, this fares determination will primarily implement a number of key government initiatives, namely the 20% cost of living fares reduction and the Young Adult Card scheme, along with some other adjustments with the aim of incentivising a return to public transport nationally.





# 2.3 The need for fares adjustments

#### Young Adult Leap Card Scheme

As part of Budget 2022, government approved the introduction of a new Young Adult Leap Card, which is intended to offer a 50% discount on fares across the public transport network for those aged 19 to 23 inclusive (up to 24<sup>th</sup> birthday). It was an objective of the NTA to provide discounted fares for all adults under 24 not just for those in 3<sup>rd</sup> level education programmes. It was supported by Comhairle na nOg, the youth council representing each of the 31 local authorities across the country, whose mission in relation to public transport is stated as, "Connecting young people across Ireland through sustainable and affordable transport solutions".

In its consideration of any change to fare structures the Authority recognises the importance of having a clear indication of what is required and what the overarching principles guiding the process are. These include:

- The introduction of Young Adult fares should be simple and easily understood by potential users;
- They should be relatively easy for the Operators to introduce and operate;
- Personalised Leap cards enable Operators to effectively manage age limits;
- The introduction of Young Adult fares should be used as an opportunity to further reduce cash handling, particularly on buses where dwell times at stops are a critical factor in the quality of service; and
- Public transport use should be encouraged among young adults with a view to ensuring they continue to use public transport as they grow older.

The process intended to support the introduction of Young Adult fares will use the existing Leap card platform. Personalised (i.e. with cardholder's photograph) Leap cards for aged based recipients (i.e. 19-23) will only need to be issued once, not annually as the current student Leap card scheme requires. Annual issuance for mature students will still be required with validation of enrolment in a qualifying course.

Currently, Leap Card has Adult, Student and Child variants with associated fares structures. The child fare category applies to customers between 5 and 18 (inclusive) and generally gives a discount of approximately 50%. The Student fare category applies to full time students of any age and generally gives a discount of approximately 25%; although there is no particular discount for single trips on city services. On these services, students do benefit from discounted daily and weekly cap and other student tickets. Conversely, young adults who are not in education on or after their 19th birthday must pay the full adult fare. This includes those young adults who are doing an apprenticeship in construction, engineering or finance etc. These young adults may be earning a wage but it is likely to be a relatively low wage and like colleges or universities students often find it difficult to meet the costs of transport. Other young adults may be in full time employment but it is likely that they will be earning at the lower end of the salary scale.

It is the view of the Authority that the introduction of a system of Young Adult fares would therefore provide the following benefits:





- Increased uptake of public transport by making it more attractive to young people and reduce their tendency to use car as their default mode;
- Reduce road accidents through increased use of safer modes; accident rates amongst younger people are much higher than average;
- A simplified and more cost effective card issuing process;
- Fares which are more equitable for all young people, including students. These young adults may
  be earning a wage but it is likely to be a relatively low wage and like students they will find it difficult
  to meet the costs of transport; and
- Effective use of PSO funds to encourage modal shift to public transport.

This determination will commence the process of simplification of age bands across all fares. These will become Child (5-18 incl.); Young Adult (19-23 incl.) and Adult. Student fares including mature students will be incorporated in the Young Adult band.

#### 20% Cost of Living fares reduction

As Ireland began to emerge from the disastrous effects of the pandemic and restrictions were gradually lifted towards the end of 2021, it was widely anticipated that Ireland would bounce back in a relatively strong manner. Economic decline had been avoided thanks largely to a booming multinational sector and higher than expected corporate tax receipts leading to projections of growth in productivity in the region of 8%-15% from the main economic think tanks.

In addition to an expected improvement in the labour market, the other main dependency of post pandemic economic recovery was the rate of inflation (i.e. the increase in price of the things individuals and households would regularly pay for). In the year to January 2022, prices have increased in Ireland by 5%, receding from a 20 year high of 5.5% in December 2021, contrary to the expectations of the European Central Bank whose assessment was for inflation to recede to a more sustainable footing of around 2% in 2022.

This has been driven primarily from the effects of post Covid demand as economies reopen, but also soaring energy prices in recent months resulting in significantly higher utility costs, and transport associated increases e.g. petrol and diesel. The CSO state that of all commodities, the cost of utilities (e.g. gas and electricity) and transportation have seen the largest increases in the past year.

In its response to rising prices across the economy, the government announced a package of measures on 10<sup>th</sup> February 2022 to mitigate against a cost of living crisis. Part of this package is to introduce a temporary reduction in fares on all PSO public transport services by an average of 20% until the end of 2022.

The 20% average reduction in fares will apply in addition to young adult associated discounts which will provide young people, aged between 19 and 23, with an average 50% discount of equivalent adult fares.





# 2.4 Taxsaver Scheme

The Taxsaver scheme has traditionally offered excellent value for regular commuters, who when purchasing monthly or annual tickets via their employer received a significant tax based incentive to use public transport. Purchases made through a salary sacrifice scheme has the effect of the customer not paying income tax or PRSI on their ticket, resulting in substantial savings. This benefit to customers had in the past the dual effect of encouraging more people to use public transport and reducing the cost for regular commuters.

The Authority recognises the likely change in working practices as we emerge from the pandemic, with many employers adopting hybrid or blended models where attendance at a physical office is not required 5 days a week. The Authority in conjunction with the relevant government departments are currently exploring options in relation to tax incentivisation in order to improve the Taxsaver proposition, as a result of evolving commuter patterns.

In advance of this and in recognition of those commuters who avail of the existing Taxsaver scheme, the 20% cost of living fares reduction will apply to all monthly and annual tickets purchased in the usual manner for travel from 1<sup>st</sup> April. Additionally, for those customers who have already purchased an annual ticket, the Authority has determined that they will be included in the discount scheme by extending these tickets by three months, which is the equivalent of a 25% fares reduction.

## **2.5** Determination by the Authority

The Authority has been working over many years now to simplify the fares across bus, rail and light rail services and to introduce a fairer distance based structure. The 2021 determination for Dublin city and the wider Dublin metropolitan area took a significant step forward in relation to achieving these objectives, through the introduction of the 90 minute fares structure.

Due to the recent announcement of a fares reduction of 20% across all fares, the Authority is not in a position to implement significant structural fares changes or address anomalies at this time. Additionally, the implementation of the Young Adult Card and associated 50% discount on all PSO subsidised services adds significantly to the complexity of these fares adjustments, one example being Irish Rail Intercity fares, the majority of which are sold online utilizing a yield management system to offer reduced fares depending on demand. Extensive manual interventions are therefore required to ensure fares are consistent across all passenger types and in accordance with the discounts envisaged by government. Similar consistency checks are also required across all other individual fares structures nationally.

In light of these complexities and the need to implement fares adjustments in as timely a manner as possible, the Authority proposes to implement all changes in a phased manner, as outlined below.

- Phase 1: Taxsaver tickets (Effective from the start of April)
  - $\circ \quad 20\% \ \text{cost of living fares reduction}$
  - Three month extension to existing annual Taxsaver tickets currently in use





- Phase 2: PSO services outside of the Greater Dublin Area (GDA) (Effective mid April)
  - o 20% cost of living fares reduction on non-Dublin city PSO services
  - o Includes: Bus Éireann, Go Ahead Dublin Commuter, Local Link and Irish Rail web-fares.
- Phase 3: PSO services within the GDA (Effective w/c 9<sup>th</sup> May)
  - $\circ$  ~ 20% cost of living fares reduction for all PSO services in the GDA
  - Launch of Young Adult Card and associated 50% discounts
  - Includes: Dublin city bus, Luas light rail, DART, Dublin and Cork commuter rail and all other Irish Rail Intercity fares.





# 3. Dublin city bus services

## 3.1 Introduction

Dublin city bus applies to services in Dublin operated by Dublin Bus and Go Ahead Ireland and the fares set out in this determination are the same for both Operators. All fares valid for one of the Operators are also valid for the other Operator. The 2021 fares determination focussed on the small number of fares adjustments necessary to support the roll out of BusConnects in Dublin, with all other national fares remaining unchanged. As such, a new two band fare structure comprising of a short distance and a 90 minute fare was implemented for bus services in Dublin. The new fares were implemented on Leap and cash. The 2022 determination will focus primarily on the implementation of the 20% cost of living fares reduction across all PSO services in 2022, and also the introduction of Young Adult fares on Leap.

## 3.2 Adult & Young Adult fares

Under the BusConnects plan the Authority determined that the fares structure in Dublin would transition into a two fare system across all modes. For Dublin city bus services this new structure was implemented in the 2021 fares determination, which seen the introduction of a new short fare (similar to the former 1-3 stage based fare) and a long distance 90 minute fare, which replaced the former 4-13 and 13+ stage based fares.

The introduction of the 90 minute adult Leap fare allows passengers to travel extensively across the Dublin city bus network, with the added benefit of free onward transfer within 90 minutes of initial tag on. As outlined in November 2021, this fare will revert to the determined level of  $\leq 2.50$ . However, the introduction of a 20% cost of living discount on all PSO fares means that this fare will be reduced to  $\leq 2.00$  in 2022, offering significant value for bus passengers. The new short distance fare, priced at  $\leq 1.60$  allows for slightly longer trips than the former 1-3 stage based fare. This fare will also be reduced to  $\leq 1.30$  in 2022, providing excellent value for hop on/hop off travel on Dublin city bus services. Following the government's announcement in Budget 2022, a new Young Adult fare will come into effect on Leap on all Dublin city bus services for the first time. A new short distance and 90 minute fare have been determined at 50% of the equivalent adult fare. Incorporating the 2022 fares discount, these fares will be introduced at just 65 cent for a short distance trip and  $\leq 1.00$  for a 90 minute journey, where free onward travel is also permissible within 90 minutes of initial tag on. For those customers who choose to pay in cash, these fares will also be reduced by an average of 20% in 2022.

All existing Rambler tickets will also benefit from the 20% cost of living fares reduction for the rest of 2022. These products may continue to be a viable option for adults on the basis that they can be used on non-consecutive days, meaning that a 30-day Rambler could be used for unlimited bus travel 5 days a week over 6 weeks, at a cost which is equivalent to the discounted weekly cap.

Dublin Bus Xpresso services are designed to allow for faster and more efficient bus travel for daily commuters, during both morning and evening rush hour traffic. These routes have fewer stops and therefore, reduce journey times between destinations. The fare on Xpresso routes reflects this faster and more direct





service with a slightly higher fare than the regular fare. This determination will see the introduction of a Young Adult Xpresso fare on Leap, which is half the price of an adult fare. In addition, the 20% cost of living fares reduction will also apply to this fare and all other Xpresso fares for adults on Leap and cash for the rest of 2022. When Xpresso fares are paid by Leap epurse, passengers will also be entitled to free onward travel on any mode within 90 minutes of their initial tag on.

Dublin Bus Nitelink routes depart from city centre locations on Friday and Saturday nights. These routes operate in a somewhat similar manner to the Xpresso routes and the Authority has determined that fares for these services will also be reduced by 20% for the rest of 2022, with the added benefit of free onward transfer within 90 minutes on any mode within the 90 minute area when passengers choose to purchase their ticket on Leap. Young Adults will also be able to travel on Nitelink services for half of the equivalent adult fare using their Leap card.

#### 3.3 Child Fares

In recognition of the need to encourage the uptake and regular use of sustainable forms of transport amongst our younger generations, the Authority introduced a single flat bus fare for children as part of the 2021 fares determination. The 80 cent Leap fare allows children to travel any distance on Dublin city bus services (including free onward travel within 90 minutes) and represented a 20 cent reduction on the former Leap fare. The determination this year will see this fare further reduced to just 65 cent in 2022 as well as lowering the child Xpresso fare to €1.00. Child cash fares will also see similar discounts in 2022.

#### 3.4 Monthly & Annuals

Travelwide monthly and annual tickets allow travel on all Dublin city bus PSO services, including those operated by Go Ahead. Multi-Operator tickets are also available within the Dublin SHZ allowing commuters to avail of two or more services such as Luas or larnród Éireann SHZ rail. Part of the BusConnects plan is to allow transfer between modes without financial penalty and, in line with this objective, the Authority have determined that over time there will be a common fare for a single service monthly or annual ticket, and a common fare for a multi-service monthly or annual ticket. In 2019 the determination for monthly and annual tickets ensured that there were no increases in fares, with some multi-Operator products seeing fares decreases. This determination will implement the 20% fares reduction, which will include monthly and annual tickets, offering much improved value for regular passengers. These tickets may also be purchased under the Taxsaver scheme where savings of up to 52% can be made, depending on the rate of tax, PRSI and USC that is paid.

#### 3.5 Iarnród Éireann Dublin Bus/Luas add-on

Commuters travelling into Dublin may also avail of the larnród Éireann Intercity add-on, which allows travel on the Luas Red Line between Heuston Station and Dublin Connolly station or George's Dock, and on Dublin





Bus route 145 from Heuston to the City Centre. These add-on tickets will also benefit from the 20% cost of living fares reduction in 2022.

#### 3.6 Summary

The 2021 fares determination focused on the introduction of the new 90 minute fares structure in Dublin, which went some way to achieving an Authority objective of the creation of a simplified and integrated fares structure, promoting seamless interchange between modes without financial penalty, for the benefit of all passengers. This year, the Authority has used the fares determination to primarily introduce Young Adult fares and also to implement the government's 20% cost of living fares reduction.

#### **3.7** Headline changes:

- Dublin's city bus services operated by Dublin Bus and Go Ahead Ireland
  - The short adult Leap fare priced at €1.60 will be discounted to €1.30, enabling passengers to travel for less between 2km and 3km on all Dublin city bus services.
  - The 90 minute Leap fare will revert to the determined level of €2.50. However, the introduction of a 20% discount on all PSO fares means that this fare will be reduced to €2.00 in 2022, offering significant value for bus passengers.
  - New Young Adult fares will be introduced on all Dublin city bus services on Leap only, comprising of single fares for short distance, 90 minute, Xpresso and Nitelink services. These are priced at approximately 50% of the equivalent adult fare. Additionally, these fares will also benefit from a 20% fares reduction in 2022, offering exceptionally good value for passengers. The Young Adult Leap 90 minute fare will be €1.00 which offers very significant value to customers.
  - The recently introduced flat child Leap fare which allows all children to travel anywhere on the Dublin city bus network with the additional benefit of a free transfer to any mode within 90 minutes of initial tag on, will be discounted from 80 cent to just 65 cent in 2022.
  - All cash single fares (including Xpresso & Nitelink) and prepaid period products (e.g. Ramblers & Visitor tickets) will also be discounted by an average of 20%.
  - Monthly and annual Dublin city bus products (including multi-Operator tickets incorporating Dublin city bus) will also be discounted by 20% in 2022, offering improved value for passengers who travel more frequently. These products may be purchased under the Taxsaver scheme, offering significant savings for commuters.

A full detailed listing of Dublin city bus fares can be seen in **Appendix A - Dublin City Bus Fares**.





# 4. Luas light rail

#### 4.1 Introduction

Luas light rail services operate on two lines in Dublin city, the green line which runs from Brides Glen to Broombridge and the red line which runs from the Point in the Docklands to Tallaght, with a spur to Citywest and a spur to Connolly rail station.

In 2004, when Luas services began, the Luas operated as a premium product, with fares to match, reflecting the level of traffic priority given to Luas. Between 2004 and 2018 Luas fares experienced more moderate increases in comparison to other forms of public transport. Bus and heavy rail fares had annual fare increases in excess of 5% for a number of years while Luas fares increased by an average of closer to 2%. This resulted in Luas fares being somewhat cheaper than other forms of public transport, especially for longer journeys.

Over the past number of years the Authority, in consultation with TII and Transdev, have worked towards simplifying the fares system on Luas light rail services and have merged a number of fare types to make it simpler and easier to understand. All of these changes have helped the travelling public to have a clearer picture of the cost of travel and made it easier for them to plan their journeys.

BusConnects will see greater movement of passengers between different transport services without penalty, and as such, it was necessary to bring Dublin city bus and Luas fares together for journeys of similar length. These adjustments were made on a gradual basis over a number of years, with changes introduced in November 2021 aligning Luas fares to that of other Operators in Dublin city for Leap customers.

#### 4.2 Adult & Young Adult fares

The 2021 fares determination seen the consolidation of pre-existing zonal fares on Leap to create the new short distance and 90 minute fare on Luas light rail services, set at  $\leq 2.50$ . Whilst the consolidation of zonal fares resulted in increases for some customers, there are significant benefits that arise from both new Leap fares namely free onward transfer within 90 minutes of initial tag on, allowing passengers to complete their journeys at no extra cost. Also, the new short fare affords journeys of greater distance compared to the former zone 1 fare, particularly on the edges of the city centre, where 2019 analysis has shown that the top ten highest demand journeys are all located on the boundary of the former 'Central' zone which now benefit from a short fare as opposed to the former zone 2 fare. The determined fare of  $\leq 2.50$  will in this determination be reduced by 20% to  $\leq 2.00$  as part of the government's cost of living fares reduction for the rest of 2022, offering a highly attractive fare for Luas passengers. The short Leap fare will also be reduced from its current level at  $\leq 1.60$  to  $\leq 1.30$ .

This determination will also see the introduction of Young Adult Leap fares on Luas light rail services for the first time. These have been determined at 50% of the equivalent adult fares and will apply for short distance and 90 minute Leap journeys. In addition, these fares will also benefit from the 20% reduction in prices for





the rest of 2022. The Young Adult Leap 90 minute fare will be €1.00 which offers very significant value to customers.

The complexity of the changes required to implement Young Adult fares and the 20% PSO wide fares reduction is such that all cash fares on Luas light rail services will remain as zonal tickets at this time (singles, returns, 1 Day, 7 Day & 30 Day). All cash fares will however benefit from the 20% fares reduction in 2022.

#### 4.3 Child Fares

As has been the case for bus and rail services in Dublin, the introduction of the new fares structure has facilitated the creation of a single flat fare for all children. The 80 cent Leap fare has enabled children to travel on Luas light rail services, offering significant savings when compared to pre-existing child fares. This new Leap fare is also a 90 minute ticket, allowing children to make free transfers for onward travel within 90 minutes of initial tag on. In compliance with government policy, this determination will see a reduction in the child Leap fare from 80 cent down to just 65 cent for the rest of 2022. Similarly, all child cash zonal fares will see similar fares reductions of 20% on average.

## 4.4 Iarnród Éireann Dublin Bus/Luas add-on

larnród Éireann Intercity customers purchasing rail tickets can opt for a Dublin Bus/Luas add-on to their rail ticket. This add-on entitles them to travel on the Luas Red Line between Heuston Station and Dublin Connolly station or George's Dock, and on Dublin Bus route 145 to the city centre. The Authority have determined that cash fares for single, return and weekly versions of these tickets will also see an average fares reduction of 20% in 2022 for adults and children.

#### 4.5 Monthly & Annuals

Monthly and annual tickets on Luas light rail services have typically offered value compared to other Operator's in the Dublin area. Multi-Operator tickets are also available allowing commuters to avail of two or more services such as Dublin city bus or larnród Éireann SHZ rail. Part of the BusConnects plan is to allow transfer between modes without financial penalty and, in line with this objective, the Authority have determined that over time there will be a common fare for a single service monthly or annual ticket, and a common fare for a multi-service monthly or annual ticket. This determination, however, will implement the 20% cost of living fares reduction in a consistent manner across all fares and as such, Luas monthly and annual tickets will continue to offer better value for Luas passengers. These tickets may also be purchased under the Taxsaver scheme where savings of up to 52% can be made, depending on the rate of tax, PRSI and USC that is paid.





## 4.6 Summary

This year, the Authority has used the fares determination to primarily introduce Young Adult fares and also to implement the government's 20% cost of living fares reduction. The 2021 determination focused on the introduction of the new fares structure for Leap customers in Dublin, which went some way to achieving an Authority objective of the creation of a simplified and integrated fares structure, promoting seamless interchange between modes without financial penalty, for the benefit of all passengers. Due to the complexity involved in the delivery of both government commitments as part of this determination, the Authority have chosen not to align cash structures for Luas services at this time.

#### 4.7 Headline changes:

#### Luas light rail services operated by Transdev

- The short adult Leap fare priced at €1.60 will be discounted to €1.30, enabling passengers to travel for less between 2km and 3km on Luas services.
- o The introduction of the 90 minute adult Leap fare allows passengers to travel extensively across the Luas network, with the added benefit of free onward transfer within 90 minutes of initial tag on. As outlined in November 2021, this fare will revert to the determined level of €2.50. However, the introduction of a 20% discount on all PSO fares means that this fare will be reduced to €2.00 in 2022, offering significant value for Luas passengers.
- New Young Adult fares will be introduced on all Luas services on Leap only, comprising of a single fare for short distance trips, and a 90 minute fares for longer and multi-leg trips. These are priced at approximately 50% of the adult equivalent fare. Additionally, these fares will also benefit from the 20% fares reduction in 2022, offering exceptionally good value for passengers. The Young Adult Leap 90 minute fare will be €1.00 which offers very significant value to customers.
- The recently introduced flat child Leap fare which allows all children to travel anywhere on the Luas network with the additional benefit of a free transfer to any mode within 90 minutes of initial tag on, will be discounted from 80 cent to just 65 cent in 2022.
- All cash single, return and prepaid period product fares (e.g. 1, 7 an7 Day tickets) will remain as zonal tickets but will also be discounted by an average of 20%.
- All Luas add-on tickets will also benefit from the 20% fares reduction in 2022.
- Monthly and annual Luas products (including multi-Operator tickets incorporating Luas) will also be discounted by 20% in 2022, offering improved value for passengers who travel more frequently. These products may be purchased under the Taxsaver scheme, offering significant savings for commuters.

# 5. larnród Éireann

## 5.1 Introduction

larnród Éireann operates heavy rail services across Ireland under contract with the NTA. Their services are broken down into commuter services, DART services and Intercity services. The 2021 fares determination focussed on the small number of fares adjustments necessary to support the roll out of BusConnects in Dublin, with all other fares remaining unchanged. As such, a new two band fare structure was implemented for Dart and commuter rail services in Dublin. The new fares were implemented initially on Leap, with changes to cash being deferred, as is the case on Luas Light rail services. The 2022 determination will focus primarily on the implementation of the 20% average fares reduction across all PSO services, and also the introduction of Young Adult fares across the Irish Rail network.

## 5.2 Adult & Young Adult Fares SHZ

The 2021 fares determination resulted in the consolidation of pre-existing zones on Leap to create the new short distance and 90 minute fare on rail services within the 90 minute fare boundary, set at  $\leq 2.50$ . Whilst the consolidation of zonal fares resulted in increases for some customers, there are significant benefits that arise from both new Leap fares namely, free onward transfer within 90 minutes of initial tag on, allowing passengers to complete their journeys at no extra cost as well as reductions in the fare paid by previous zone 4 passengers. The determined fare of  $\leq 2.50$  will in this determination be reduced by 20% to  $\leq 2.00$  as part of the government's cost of living fares reduction for the rest of 2022, offering a highly attractive fare for passengers in the Dublin area. The short Leap fare will also be reduced from its current level at  $\leq 1.60$  to  $\leq 1.30$ .

Passengers travelling between stations on zone 5 and zone 6 fares are undertaking journeys of between 24 and 60+ kilometers. These trips are longer than most journeys on Dublin city bus or Luas, and therefore, the fares for these two zones sit outside the 90 minute fare boundary. The Authority determined in 2021 that adult Leap single fares for zone 5 and zone 6 fare will remain at 2018 prices. This determination will also see these fares reduced by an average of 20% in 2022, offering even better value for passengers. In addition, the Authority has sought to ensure a fairer distance based fares structure and will in this determination adjust journeys between Greystones and city centre stations (Pearse, Tara & Connolly) from zone 6 to zone 5. The correction of this anomaly will ensure consistency with zone 5 journeys of a similar distance, such as Skerries to the city centre.

This determination will also see the introduction of Young Adult Leap fares in the SHZ in Dublin for the first time. These have been determined at 50% of the equivalent adult fares and will apply for short distance, 90 minute, zone 5 and zone 6 journeys. In addition, these fares will also see a further 20% reduction in prices for the rest of 2022.





The complexity of the changes required to implement Young Adult fares and the 20% PSO wide fares reduction is such that all cash fares on rail services in Dublin will remain as zonal tickets at this time (singles, returns, 1 Day, 3 Day & 7 Day). All cash fares will however benefit from the 20% fares reduction in 2022.

#### 5.3 Child Fares SHZ

As has been the case for bus and Luas light rail services in Dublin, the introduction of the new fares structure has facilitated the creation of a single flat fare for all children. The 80 cent Leap fare has enabled children to travel on all Dart and heavy rail services in the Short Hope Zone, offering significant savings when compared to pre-existing child fares. For example, the flat 0.80 Leap fare includes travel on zone 5 & 6 rail services, which were previously priced at 1.43 and 1.94. This new Leap fare is also a 90 minute ticket, allowing children to make free transfers for onward travel within 90 minutes of initial tag on. In compliance with government policy, this determination will see a reduction in the child Leap fare from 80 cent down to 65 cent for the rest of 2022. Similarly, all child cash zonal fares will see similar fares reductions of 20% on average.

#### 5.4 Iarnród Éireann Dublin Bus/Luas add-on

larnród Éireann Intercity customers purchasing rail tickets can opt for a Dublin Bus/Luas add-on to their rail ticket. This add-on entitles them to travel on the Luas Red Line between Heuston Station and Dublin Connolly station or George's Dock, and on Dublin Bus route 145 to the city centre. The Authority have determined that cash fares for single, return and weekly versions of these tickets will also see an average fares reduction of 20% in 2022 for adults and children.

#### 5.5 Intercity - Singles, Returns & Web Fares

Intercity fares are based on the quality and frequency of service and are divided into 3 categories namely express routes, economy 1 and economy 2. In recent years the Authority has made adjustments across each fares category and passenger type in order to meet certain objectives such as smoothing the boundary between Intercity and Dublin SHZ fares, reducing the disparity between fares levels across service types as overall service levels improve, and making adjustments which facilitate better yield management of online fares and disperse demand across peak and shoulder peak services. Whilst there is more that can be done to address long standing anomalies and improve the offering on Intercity services, this fares determination will prioritise, due to the complexity involved, the introduction of both Young Adult fares and the PSO wide 20% average fares reduction.

The majority of Intercity fares (single, day return and open return) may be purchased online in advance, as part of their customer first programme. These offer tickets at three different price points to their customers when purchasing in advance, providing significant savings over standard booking office fares. The Authority in conjunction with Irish Rail have sought to ensure that newly determined Young Adult web fares provide appropriate levels of discount compared to existing adult and pre-existing student fares. As existing web





fares are already heavily discounted, newly introduced Young Adult single and returns will be offered at 50% of the equivalent adult fully flexible fare, with semi flexible fares reduced by a range to ensure these tickets remain cheaper than flexible tickets, and low web fares which are already discounted by 35% compared to fully flexible options, having an additional variable discount applied.

Intercity fares will also see an average discount of 20% in line with the government's cost of living fares reduction in 2022. These discounts will be in addition to already heavily discounted web fares and for this reason discounts will be applied in the same manner as above with fully flexible fares seeing an average 20% reduction, while semi flexible and low web fares will have a further variable discount applied.

With the approval of the Authority, the maximum web fare for Intercity services will continue to be €49.99, however the introduction of Young Adult fares and the 20% cost of living discount in 2022 ensures that web fares will become significantly cheaper and continue to represent excellent value for passengers who choose to purchase online in advance.

## 5.6 Monthly and Annual Tickets - SHZ and Intercity

larnród Éireann has a large range of monthly and annual tickets both for use on their own services and a number of multi-Operator services. This includes monthly and annual tickets which allow commuters to avail of two or more services such as Dublin city bus, Luas, Iarnród Éireann SHZ rail or Bus Éireann/Go Ahead.

Part of the BusConnects plan is to allow transfer between modes without financial penalty and, in line with this objective, the Authority have determined that over time there will be a common fare for a single service monthly or annual ticket, and a common fare for a multi-service monthly or annual ticket. In 2019 the determination for monthly and annual tickets ensured that there were no increases in fares, with some multi-Operator products seeing fares decreases. This determination will implement the 20% fares reduction, which will include monthly and annual tickets, offering much improved value for regular passengers.

Intercity Adult monthly and annual point to point tickets have not seen an increase in fares since 2018. This is in recognition of the fact that many commuters who purchase monthly and annual tickets from these zones are travelling into the capital city and may have to use another form of public transport to reach their destination. These tickets will also benefit from the 20% fares reduction in 2022.

It should be remembered that Adult monthly and annual tickets can be purchased under the Taxsaver scheme and where this is done, savings of between 30% and 52% can be made depending on the level of tax, PRSI and USC that you pay. In the case of a SHZ annual ticket which allows unlimited travel in the Dublin Short Hop Zone at a discounted cost of  $\leq$ 1,150 in 2022, one can save up to 52% or almost  $\leq$ 600 under the Taxsaver scheme with the result that the ticket can cost as little as  $\leq$ 552 net after tax, PRSI and USC. That works out at just over  $\leq$ 10 per week for the entire larnród Éireann SHZ travel.





# 5.7 Cork Commuter Zone

In 2012, the Authority began the process of implementing a more distance based fare scheme in the SHZ in Dublin, in order to ensure that people pay a fairer price for the journey that they make. The Authority intends to address the disparities which exist in terms of relative fares per kilometre travelled in Cork and in Dublin in order to tackle long standing imbalances between both commuter zones, with adjustments for both rail and bus services coinciding and aligning with strategic policy for public transport in the wider Cork metropolitan area in the coming years.

The Authority also recognises the evolving picture in relation to commuting to and from Cork city and in that regard have determined that Mallow be introduced into the commuter area for rail services this year. One new zone will be created allowing passengers to travel from Mallow to Cork and all other stations in the commuter area for fares which are similar to that of the Short Hop Zone in Dublin. New zonal Leap fares will be introduced for all passenger types including Young Adults throughout the commuter area. In addition, all fares will also benefit from the 20% fares reduction in 2022. This means that passengers will be able to travel from Mallow to Cork Kent or any other station within the commuter area for as little as €3.90 on Leap for Adults and just €1.95 for Young Adults.

#### 5.8 Multi-Service tickets – Cork area

larnród Éireann and Bus Éireann offer combined rail and bus services in the Cork area. The rail services are from Cobh and Midleton, and the bus services are the Bus Éireann Cork city services. With the expansion of the Cork city bus fare zone in December 2017, this has increased the scope of these tickets and makes them excellent value. Passengers boarding at all stations along the Cobh/Midleton rail line have the option to use either bus or rail to undertake their journey. For consistency, it was proposed that these combined tickets would be extended to cover the PSO bus services to Midleton also, thus giving customers the option to use bus or rail between Cork and Midleton, in addition to unlimited travel within the Cork City Red Zone. In its Determination this year, the Authority will be discounting the cost of the 1 Day, monthly and annual integrated tickets by 20% in line with the cost of living fares reduction for 2022.

#### 5.9 Maximum Leap Commuter fare

Passengers who use Leap on larnród Éireann in the SHZ in Dublin need to tag-on when going onto the train and tag-off when exiting the train platform. In this way, the correct fare will be charged as the Leap card will know the origin and destination station and be able to calculate the correct fare. If a passenger does not tagoff when disembarking from the train they will be charged the maximum Leap fare.

The Authority has determined that in line with the 20% reduction across all PSO fares, that the maximum Leap deduction will also be discounted from  $\leq 5.00$  to  $\leq 4.00$  for adults. In addition, a new Young Adult maximum fare has been determined at  $\leq 2.50$ , which is also discounted to  $\leq 2.00$  in 2022.





## 5.10 Summary

This year, the Authority has used the fares determination to primarily introduce Young Adult fares and also to implement the government's 20% cost of living fares reduction. The 2021 determination focused on the introduction of the new fares structure for Leap customers in Dublin, which went some way to achieving an Authority objective of the creation of a simplified and integrated fares structure, promoting seamless interchange between modes without financial penalty, for the benefit of all passengers. Due to the complexity involved in the delivery of both government commitments as part of this determination, the Authority have chosen not to align cash structures for rail services in Dublin at this time. The Authority have, however, been able to make a significant change in the Cork commuter area with the inclusion of Mallow in the commuter fare area, which will benefit passengers significantly in the Cork region.

#### 5.11 Headline changes:

#### Rail Services operated by larnród Éireann

- The short adult Leap fare priced at €1.60 will be discounted to €1.30, enabling passengers to travel for less between 2km and 3km on all Dart and commuter rail services in the Dublin area.
- The 90 minute Leap fare will revert to the determined level of €2.50. However, the introduction of a 20% discount on all PSO fares means that this fare will be reduced to €2.00 in 2022, offering significant value for rail passengers. The 90 minute fare will continue to apply within the 90 minute fare boundary (See Appendix M Dublin 90 minute fare boundary).
- Existing zones 5 & 6 journeys remain in the new Dublin fares structure for longer journeys, with associated fares also benefitting from the 20% fares reduction. Those choosing to purchase zones 5 or 6 single tickets on Leap will also be afforded free transfers within 90 minutes of initial tag on.
- For consistency across the SHZ in Dublin, journeys between Greystones and the city centre (Pearse, Tara & Connolly) will be adjusted from zone 6 to zone 5, providing savings for passengers.
- New Young Adult fares will be introduced on all rail services in Dublin on Leap only, comprising of single fares for short distance, 90 minute, zone 5 and zone 6 journeys. These are priced at approximately 50% of the adult equivalent fare. Additionally, these fares will also benefit from a 20% fares reduction in 2022, offering exceptionally good value for passengers.
- The recently introduced flat child Leap fare which allows all children to travel anywhere on rail services within the SHZ with the additional benefit of a free transfer to any mode within 90 minutes of initial tag on, will be discounted from 80 cent to just 65 cent in 2022.
- All cash single, return and prepaid period product fares (e.g. 1 & 7 day tickets) will remain as zonal tickets but will also be discounted by an average of 20%.
- Monthly and annual rail products (including multi-Operator tickets incorporating rail) will also be discounted by 20% in 2022, offering improved value for passengers who travel more frequently. These products may be purchased under the Taxsaver scheme, offering significant savings for commuters.
- Mallow will be brought into the commuter rail area in Cork. This will see the addition of one new zone, with the introduction of Leap and cash fares to complement the existing ticket offering. This





will mean that an adult will be able to travel from Mallow to any station within the commuter area for just €3.90 when paying on Leap.

- Cork commuter passengers will also benefit from the introduction of Young Adult fares on Leap, and in addition, all fares will see a reduction of 20% in 2022.
- Intercity passengers will see the introduction of Young Adult fares on all services, with singles, day return and open returns being made available both from the booking office and for purchase online in advance. All fares on Intercity services will also see the 20% fares reduction implemented for the rest of the year.

A full detailed listing of larnród Éireann fares can be seen in Appendix C - Rail fares.





# 6. Daily and Weekly Fare Capping

Leap fare capping is where there is a maximum charge per day or week for journeys undertaken with a Leap card on a public transport Operator. So, if a customer makes a lot of trips and pays for them with their Leap card during a daily or weekly (Monday to Sunday) time period, the amount they spend will be capped and the Leap card system will make sure they never pay more than the fare cap limit.

Fare capping was introduced in 2014 on larnród Éireann services and is currently available in the SHZ in Dublin along with the Luas and Dublin city bus services. The same capping values for rail services in Dublin also apply on Cork commuter rail services. Capping aims to make paying for public transport easier as users will be able to Pay-As-You-Go without having to decide in advance if they wish to commit to the up-front expense of buying a daily or weekly ticket. Multi-Operator capping allows travel on a combination of Operators from Dublin city bus, Luas and DART & Short Hop Commuter Rail. There has been no change in Leap fare caps since 2013 however the Authority has determined that in line with the government decision to introduce Young Adult fares and also reduce all PSO fares by 20% this year that these changes should also be reflected across all Leap fare caps.

Accordingly, there will be a new Young Adult caps across all modes for daily and weekly travel. In accordance with government policy, these have been determined to be 50% of the equivalent adult cap. In addition, all caps (including Young Adult caps) have been reduced by an average of 20% this year. The tables below set out all determined and discounted caps for bus and rail services.

# 7. Bus Services outside Dublin

## 7.1 Introduction

Public Service Obligation (PSO) services are provided primarily by Bus Éireann under public service contract to the National Transport Authority. These services are not commercial and attract a PSO payment in line with EU regulation 1370/07. They comprise:

- Regional city services in Cork, Limerick, and Galway
- Stage carriage (i.e. multi-stop) services which include:
  - Eastern region commuter services within the GDA
  - Town services in Navan, Dundalk, Drogheda, Balbriggan, Sligo and Athlone
  - Commuter services from satellite towns and villages to the main gateway cities
  - Non- commercial scheduled services throughout Ireland

Go Ahead Ireland successfully tendered to operate a number of routes from Co Kildare to Dublin city (Dublin Commuter) which were previously operated by Bus Éireann, with services commencing operation in September 2019. Fares on these services are the same as those charged by Bus Éireann with any monthly or annual ticket purchased when Bus Éireann were operating the route being valid on Go Ahead Ireland services. Stops and routes are also largely the same, with some innovations to improve the nature of the public transport offer in the region.

The Authority also undertook a further public tender competition during 2019 for services in Waterford City. Bus Éireann were subsequently awarded this contract on a gross cost contract basis. Similar to that of Go Ahead Ireland and Dublin Commuter services, fares charged are the same as those previously charged by Bus Éireann, with period tickets continuing to be valid.

Where reference is made to Bus Éireann in this chapter it also includes Go-Ahead Ireland (Dublin Commuter) and Bus Éireann (Waterford City).

The 2021 fares determination focussed on the small number of fares adjustments necessary to support the roll out of BusConnects in Dublin, with all other fares including all those outside of the Dublin area remaining unchanged. The 2022 determination will focus primarily on the implementation of the 20% average fares reduction across all PSO services, and also the introduction of Young Adult fares across the national bus network.





# 7.2 Regional City Fares

Leap fares were first introduced to regional cities in February 2014. Adult Leap fares have remained close to the same level since that time with the one and only adjustment being made in 2018. This year's determination will see the main adult city fare of  $\leq 1.68$  being reduced to  $\leq 1.35$  for the remainder of 2022 as part of the government's cost of living fares reduction, thus offering excellent value for passengers on Leap.

The Authority has also maintained its position in respect of children's fares since their introduction in 2014, with fares having remained the same since that time. This year, the Authority will take a further positive step by introducing a new flat child Leap and cash fare, to consolidate the existing standard, outer and schoolchild fare, allowing all children travel on Bus Éireann city services regardless of the distance of the journey within the city fare zone. The new Leap fare has been determined at 80 cent, with a discounted price of just 65 cent for the rest of 2022.

In addition, Young Adult fares will be introduced on Leap in all regional cities, with fares for both standard and outer zone travel being half that of the equivalent adult fare. Other Leap fares including 1 Day and 7 Day products will be discounted from their existing levels by an average of 20% for the remainder of 2022 for all passengers.

City commuters will also benefit from the 20% fares reduction with all monthly and annual regional city fares being discounted for the remainder of 2022. It should be remembered that Adult monthly and annual tickets can be purchased under the Taxsaver scheme and where this is done, savings of between 30% and 52% can be made depending on the level of tax, PRSI and USC that you pay.

## 7.3 Stage Carriage

Stage Carriage fares are those fares which apply on the PSO network operated by Bus Éireann and Go Ahead Ireland network outside of the regional cities, including the Dublin commuter area. The Authority has successfully implemented a range of adjustments to stage carriage fares since 2015 to consolidate both fare stages and ticket types to simplify the product offering, ensure appropriate discounting is applied for students and children and to ensure that Leap discount is maintained at 30% relative to cash for all fares. This determination will see the introduction of a new Young Adult Leap single fare for the first time on stage carriage services. This will be priced at 50% of the equivalent adult Leap fare across all fare bands. In addition, these fares along with all other stage carriage fares (all singles, returns, 10 Journey, 1 & 7 Day tickets) will benefit from the 20% cost of living fares reduction in 2022, offering exceptional value for passengers. For context, discounted 2022 adult single cash fares will be on average 18% cheaper than the equivalent fares in 2013.

Commuters on stage carriage and Dublin commuter services will also benefit from the 20% fares reduction with all monthly and annual fares being discounted for the remainder of 2022. It should be remembered that Adult monthly and annual tickets can be purchased under the Taxsaver scheme and where this is done, savings of between 30% and 52% can be made depending on the level of tax, PRSI and USC that you pay.





# 7.4 Bus Éireann Town Services

Bus Éireann provides town services in six towns around the country namely Athlone, Balbriggan, Drogheda, Dundalk, Navan and Sligo. Over the past number of years', the various adult and single fares in these towns have been set at the same rate for all towns, and Leap fares have also been introduced to ensure passengers get excellent value.

This year's cost of living discounts will see even better value for the rest of 2022, with the standard adult Leap fare being reduced from €1.40 down to €1.10, with equivalent cash fares also seeing the same level of discount. New Young Adult fares will also be introduced on Leap on all Town services, with the standard Young Adult Leap single being priced at just 55 cent for this year. As with that of city services, the Authority will also consolidate both child fares on Town services, with a new flat fare, priced at just 55 cent on Leap and 90 cent on cash for this year.

## 7.5 Mobile-Ticketing

In line with its commitment to improving customer experience of public transport through transformation of fare structures and increased incentive towards the use of Leap and other innovative ticketing solutions, the Authority has introduced mobile ticketing (M-ticketing) to a number of bus services operated by Bus Éireann on the stage carriage network, towns and in our regional cities, as part of its Next Generation Ticketing (NGT) Programme. NGT aims to introduce new and more flexible ticketing systems and provide additional ways for passengers to pay for their travel, such as bank debit / credit card, smartphone or Leap Card. The mobile app, TFI-GO, allows customers to purchase single, weekly and 10 Journey tickets with roll out to a greater number of services in the coming months. The Authority has determined that customers will receive 'best value' fares via the M-Ticketing mobile app for single and 10 Journey tickets, ensuring that passengers will always pay the lowest fare available, whether this be a Leap equivalent fare or existing cash fare for 10 Journey tickets. In line with all other PSO fares, those purchased on the M-ticketing platform will also be discounted by an average of 20% in 2022.





# 7.6 Summary

As previously highlighted, the Authority has decided that in light of the Covid-19 global pandemic and the impact on passenger confidence, that fares outside of the Dublin area were not be adjusted in 2019, meaning that fares on these services have remained at levels last determined in 2018. This year, the Authority has used the fares determination to primarily introduce Young Adult fares and also to implement the government's 20% cost of living fares reduction. The Authority have, however, been able to make improvements to the fares offering through the consolidation of the child fare in regional cities and towns, which in conjunction with the 20% discounts this year will significantly benefit passengers.

## 7.7 Headline Changes:

Bus services operating outside Dublin operated in the main by Bus Éireann & Go Ahead Ireland

#### • Regional cities

- ✓ All city cash and Leap fares will benefit from the Government's 20% cost of living fares reduction in 2022. This is inclusive of all singles, daily, weekly, monthly and annual tickets.
- ✓ New Young Adult fares will be introduced on Leap, offering 50% discount on equivalent adult Leap fares for both standard and outer zone journeys. These will also see a further 20% fares reduction in 2022, offering significant value for passengers.
- ✓ Child fares will be consolidated to become a flat child fare for all city journeys, including the retiral of the schoolchild fare on both cash and Leap. The new flat child Leap fare has been determined at 80 cent in line with Dublin and will be further reduced to 65 cent during 2022.

#### • Town services

- ✓ All town cash and Leap single fares will benefit from the Government's 20% cost of living fares reduction in 2022.
- ✓ New Young Adult fares will also be introduced on Leap, offering 50% discount on equivalent adult Leap fares for both standard and outer zone journeys. These will also see a further 20% fares reduction in 2022, offering significant value for passengers.
- ✓ Child fares will be also be consolidated to become a flat child fare for all town journeys, The new flat child Leap fare has been determined at 70 cent as journeys are typically less than that of city services and will be further reduced to 55 cent during 2022.

#### • Stage Carriage

- ✓ All stage carriage single, day return and open return fares will see an average 20% discount in 2022 for all passengers.
- ✓ In addition, a new Young Adult single fare will apply on Leap, which will equate to 50% of the discounted adult fare, offering significant value for passengers.
- ✓ 10 Journey tickets cash will also be reduced by an average of 20% for all passengers.
- ✓ Regular commuters will also benefit from the 20% fares reduction on all monthly and annual point to point products, which offer very good value, particularly when purchased through the Taxsaver scheme.





# 8. Other tendered PSO Services

#### 8.1 Introduction

There are a number of smaller bus services provided under a public service contract to the Authority. The routes outlined below are operated on behalf of the Authority.

- Route 817 Kilkenny to Dublin Bernard Kavanagh & Sons Ltd
- Route 975 Cavan to Longford Wharton's Travel Ltd
- Route 139 Naas to Blanchardstown J.J. Kavanagh & Sons Ltd
- Route 197 Swords to Ashbourne Go Ahead Ireland
- Routes KK1 & KK2 Kilkenny city services City Direct Ltd

The Authority conducts periodic reviews of fares on tendered PSO services outlined above, the structures for which are aligned to that of Bus Éireann and Dublin city bus services where the footprint of these services overlap. In accordance with the government's cost of living fares reduction for all PSO services, fares have been discounted by an average of 20% on each of the aforementioned services.

In addition, new Young Adult fares have been introduced on the 139, 197 and Kilkenny services where Leap fares are currently provided. On services where Leap fares are not currently offered (817 and 975), existing child fares or fares which are 50% of the equivalent adult fare will be offered to those passengers in possession of a Young Adult Card or an existing Student Leap Card.


