

Application to Nominate a Person in the Event of a Death of a Licence Holder

This form shall only be used by a living licence holder to appoint a nominee onto a vehicle licence, who may apply to the NTA to continue to operate the licence, in the event of the licence holder's death. Any nomination must be confirmed by the NTA prior to the licence holders death, to be valid.

Licences in company names cannot use the Section 15 Nomination process.

All the standard licensing criteria will apply to the nominee should they make such an application, e.g. the vehicle age, vehicle suitability, insurance and tax clearance status. Please see the website www.nationaltransport.ie for further details.
