

S.I. No. [•] Taxi Regulation (Maximum Fares) Order [•]

The National Transport Authority, in exercise of the powers conferred on it by section 24 of the Taxi Regulation Acts 2013 and 2016 (No. 37 of 2013 as amended), hereby makes the following order:

1. This Order may be cited as the Taxi Regulation (Maximum Fares) Order [•].
2. This Order shall come into operation on [•].
3. In this Order “public holiday” has the same meaning as it has in paragraphs 1 and 2 of the Second Schedule to the Organisation of Working Time Act 1997 with the addition, where a public holiday falls on a Sunday, of the following weekday.
4. The fares contained in the Schedule are fixed as the maximum fares and charges that may be charged by the driver of a taxi in respect of a journey undertaken in the State.
