

## **CLONGRiffin TO CITY CENTRE CORE BUS CORRIDOR SCHEME**

The National Transport Authority (NTA) has applied under Section 51(2) of the Roads Act 1993 (as amended) to An Bord Pleanála ('the Board') for approval in relation to a proposed road development consisting of: The construction of the Clongriffin to City Centre Core Bus Corridor Scheme which has an overall length of approximately 5.7km, and is routed along the R107 Malahide Road from Mayne River Avenue – R107 Malahide Road Junction to the junction with Marino Mart - Fairview and also routed for cyclists via the junction with Malahide Road-Brian Road along Carleton Road, St Aidan's Park, Haverty Road and Marglann Marino, all in the County of Dublin and within the Dublin City Council (DCC) administrative area, comprising inter alia:

- 5.7km (two-way) of bus priority infrastructure and traffic management;
- 11.9km (total both directions) of cycling infrastructure and facilities;
- Provision of new/refurbished pedestrian facilities and footpaths along the scheme and associated ancillary works;
- Provision of 15 junction upgrades including conversion of two existing large roundabouts to signalised junctions and associated ancillary works;
- Provision of 31 new/refurbished raised table side entry facilities;
- Reconfiguration of existing bus stops resulting in 30 number new bus stop facilities;
- Public Realm works including landscaping, planting, street furniture, street lighting, retaining walls, boundary walls and sustainable urban drainage (SUDs) measures;
- Roads associated earthworks including excavation of unacceptable material, importation of material, temporary storage of materials;
- Provision of road pavement, signing, lining and ancillary works;
- Provision of gates, fencing and boundary treatment works;
- Provision of new and diverted drainage infrastructure;
- Diversion of utilities and services including associated ancillary works; and
- Construction of accommodation works including boundary treatment and ancillary grading and landscaping works; together with all ancillary and consequential works associated therewith.

The location of the proposed road development is illustrated in the accompanying map. The NTA has submitted to the Board the Environmental Impact Assessment Report prepared in accordance with Section 50 of the Roads Act 1993 (as amended) and Directive 2011/92/EU of the European Parliament and of the Council of 13 December 2011 on the assessment of the effects of certain public and private projects on the environment as amended by Directive 2014/52/EU of the European Parliament and of the Council of 16 April 2014 in respect of the proposed road development.

A Natura Impact Statement has also been prepared and has been submitted to the Board in respect of the proposed road development under Part XAB of the Planning and Development Act 2000 (as amended).

Any submissions/observations must be accompanied by a fee of €50 and must be received by the Board not later than **5.30 p.m. on the 2nd June 2022**. This fee will not apply to certain prescribed bodies including those specified in Section 51(3)(b) of the Roads Act 1993 (as amended) or to landowners and others with a legal interest in land who are objecting to compulsory acquisition of land in which they have such an interest in a compulsory acquisition case.



The National Transport Authority (hereinafter referred to as the “NTA”) in exercise of the powers conferred upon them by Section 76 of the Housing Act, 1966 , and the Third Schedule thereto, as extended by Section 10 of the Local Government (No. 2) Act, 1960 as substituted by Section 86 of the Housing Act, 1966 as amended by Section 6 and the Second Schedule to the Roads Act, 1993 and as amended by the Planning and Development Act, 2000 (as amended), Section 184 of the Local Government Act 2001 and Section 44 of the Dublin Transport Authority Act 2008 (as amended), have made an order entitled as above which is about to be submitted to An Bord Pleanála for confirmation.

If confirmed, the order will authorise the NTA to acquire compulsorily the land and/or rights described in Part I, Part II and Part IV (Section A) of the Schedule hereto for the purposes of construction of the Clongriffin to City Centre Core Bus Corridor Scheme for the purposes of facilitating public transport, and together with all ancillary and consequential works associated therewith. The scheme has an overall length of approximately 5.7km and is routed along the R107 Malahide Road from Mayne River Avenue – R107 Malahide Road junction to the junction with Marino Mart – Fairview and also routed for cyclists via the junction with Malahide Road-Brian Road along Carleton Road, St Aidans Park, Haverty Road and Marglann Marino all in the County of Dublin.

Owners, lessees and occupiers of the land and/or rights described in Part I, Part II and Part IV of the Schedule will receive individual written notice.

The order will authorise the NTA to extinguish the public rights described in Part III (Section A) of the Schedule hereto, by order made by it after it has acquired the land, where the said public rights are over the land so acquired or any part thereof, or over land adjacent to or associated with the land so acquired or any part thereof.

- until it has considered the objection(s).

An Bord Pleanála has an absolute discretion under Section 218 of the Planning and Development Act 2000 (as amended) to hold an oral hearing.

Before making its decision on an application to confirm the Compulsory Purchase Order, the Board must consider any objection made and not withdrawn, any additional submissions or observations made pursuant to a request by the Board under Section 217A of the Planning and Development Act 2000 (as amended) and any report of the person who held the oral hearing, if such an oral hearing takes place.

The Board, if it thinks fit, may confirm the compulsory acquisition or any part thereof, with or without conditions or modifications, or to annul the compulsory acquisition or any part thereof.

An Environmental Impact Assessment Report, and a Natura Impact Statement, for which separate public notice has been given, have been prepared in respect of the development which it is proposed to carry out on the land. Evidence in relation to (i) the likely effects on the environment of the proposed development, (ii) the implication of the proposed development for proper planning and sustainable development in the area in which it is proposed to situate the proposed development and (iii) the likely significant effects of the proposed development on European Sites may be heard at any oral hearing, that may be held.
