1 Introduction

NTA is responsible for the regulation of the SPSV industry in Ireland. As at 31 March, the Small Public Service Vehicle (SPSV) fleet comprised 22,179 taxis, hackneys and limousines in active and inactive licence status (i.e. eligible to be renewed). The Taxi Regulation (Small Public Service Vehicle) Regulations 2015 specify the maximum permissible age limits for operating a vehicle as an SPSV. 763 of the fleet vehicles will reach their end of life by the end of 2020. This public consultation concerns only those vehicles.

Having regard to the Covid-19 pandemic, and in order to mitigate one part of the adverse economic consequences to the SPSV industry likely to result from the spread of that disease, NTA would like to make an exceptional legal provision, the Small Public Service Vehicle (Emergency Measure Covid-19) Regulations 2020, in relation to maximum permissible age limits.

The purpose of the Small Public Service Vehicle (Emergency Measure Covid -19) Regulations 2020 is to temporarily amend Regulation 31 of the Taxi Regulation (Small Public Service Vehicle) Regulations 2015, Maximum Permissible Age Requirements. This amendment is intended to be made as an exceptional provision and emergency measure resultant from the COVID-19 pandemic, noting that public transport, specifically including small public service vehicles, is deemed by Government an essential service.

The "maximum permissible age" in this context means the age of a taxi or hackney vehicle beyond which that vehicle may not be licensed as a small public service vehicle. Once a taxi or hackney reaches its final operation date, the licence holder may not apply to NTA for the renewal of a vehicle licence on that vehicle. A younger replacement vehicle must be purchased, and both a roadworthiness test (NCT) and an SPSV initial suitability test completed.

In the context of the COVID-19 pandemic and associated extraordinary economic circumstances being experienced by the regulated industry, including the rescinding of approved bank loans and the expected difficulty in receiving loan approval on foot of the current crisis, together with the ongoing unavailability of NCT tests, SPSV suitability inspections and VRT inspections , NTA considered extending the Maximum Permissible Age Requirements by one (1) year for licences with expiry dates from 13 March to 31 December 2020 worthy of public consultation. The draft regulation is time-bound and will automatically fall away after 31 December 2020.

2 Background

Regulation 31 (*Maximum permissible age requirements*) of S.I. No. 33/2015 - Taxi Regulation (Small Public Service Vehicle) Regulations 2015 was implemented in an effort to increase vehicle standards within the national taxi and hackney fleet. The limousine licence category is exempt from this Regulation.

Where a standard taxi or hackney vehicle licence was first granted before 1 January 2009 and a vehicle was associated with that licence on 1 January 2013, that vehicle can be licensed up to the 15th anniversary of the date of its first registration. In all other cases vehicle standard taxi or hackney can be licensed up to the 10th anniversary of the date of its first registration.

For a wheelchair accessible vehicle associated with a licence on 1 April 2014, there is no maximum age limit. For all other wheelchair accessible taxis and wheelchair accessible hackneys the maximum age limit is 15 years from the date of first registration of the vehicle.

The result of the changes to Regulation 31 of the Taxi Regulation (Small Public Service Vehicle) Regulations 2015 would, for 763 vehicle licences expiring to 31 December 2020, be that the associated vehicle would remain eligible to be licenced for one year more than it is currently, all other obligations met, as follows:

- standard taxi/hackney and local area hackney until 11 years from the date of first registration of the vehicle;
- 2. wheelchair accessible taxi/hackney until 16 years from the date of first registration of the vehicle; and
- certain other very limited standalone cases until 16 years from the date of first registration of the vehicle.

The age of the vehicle is calculated from the exact date on which it was first registered (day, month and year).

3 Consultation process and outcome

The period of the industry consultation ran from 3 April 2020 to 24 April 2020 inclusive. On 3 April 2020, NTA published the Draft Small Public Service Vehicle (Emergency Measure COVID-19) Regulation 2020, together with the information detailed above on the public consultation section of NTA's website. Also on that day, a text message was issued to 17,987¹ SPSV vehicle licence holders notifying them of the public consultation. Representations on the draft Small Public Service Vehicle (Emergency Measure COVID-19) Regulation 2020 were invited from any interested parties by submission form on NTA's website. NTA also consulted directly with the Department of Transport, Tourism and Sport and the Advisory Committee on SPSVs.

Submissions from 931 parties were received during the consultation process. All submissions have been referenced in this report. An online form allowed each interested party to make their representation in a free-text box in addition to selecting an option to agree or disagree with the proposal.

¹ This figure is lower than the total number of SPSV vehicle licences as many individuals/companies hold a number of vehicle licences and received a single notification.

83% of those who completed the online consultation agreed with the proposal. **17%** disagreed, either in full (4%), providing modified suggestions (9 %) or providing no clear comment on the proposal.

4 Submissions

The majority of the 931 representations received took the opportunity to comment in the free text box provided. A categorisation of the comments provided which were relevant to this consultation follows.

Agree

Approximately **770 (83%)** agreed with the proposal. Some submissions also included commentary relating to the consultation.

- 2% suggested all regulation on vehicle age be abolished;
- 4% suggested a permanent increase in the Maximum Permissible Age rule for various limits up to 15 years;
- 2% suggested a longer duration for the proposed regulation; and
- 2% suggested a Maximum Permissible Age for various limits up to 15 years for all vehicles in the proposed regulation.

Modify

Approximately **86 (9%)** of the free text submissions linked to the "Disagree" option requested a modification on the proposed draft:

- 6% suggested a permanent increase in the Maximum Permissible Age rule for various limits up to 16 years;
- 2% suggested a longer duration for the proposed regulation;
- 1% suggested all regulation on vehicle age be abolished; and
- 1 submission stated "If an exemption is warranted it should be no longer than 6 months".

Disagree

Approximately **38 (4%)** of representations disagreed with the proposal for the following reasons:

- 3% stated that the Draft Regulation would lead to a reduction in vehicle standards; and
- 1% stated they believed this would be unfair to other SPSV vehicle licence holders.
