**1. Minutes and Matters Arising.**

The minutes of the meeting held on the 31<sup>st</sup> of March were approved without amendment. A query was raised in relation to the ratio of drivers per 1,000 population in the UK. Does the figure of 4.4 drivers per thousand population include private hire/uber? The NTA will be asked to clarify.

**2. Local Area Hackneys.**

The Committee agreed that this matter should be closed for the short-medium term. The Committee agreed that all necessary measures had been taken by the NTA and that nothing further can be done in the short- medium term to increase uptake of the local area hackney licences. The Chair will submit an appropriate report to the NTA.

**3. Local Area Hackneys.**

The Committee agreed that it would be useful to get a presentation on smart taxi roof signs. The Chair agreed to invite one of the main providers to give a presentation at a future meeting.

**4. Dublin Airport Permits**

Dublin Airport Authority is seeking applications for airport permits from WAV's only. There was a concern among some Committee members that this might impact on supply of WAV's in other areas around the city. The NTA noted that as the ranks and holding areas at the airport are numerically constrained and taxis are dropping off in other areas of the city, this should not impact on the

availability of WAV's in other areas of the city. James Cawley agreed to liaise with Joan Carthy to discuss this issue and will come back to the Committee on this issue.
