2. Minutes of previous meeting

The draft minutes of the Board meeting held on 16th June 2023 were approved.

3. Matters Arising & Board Schedule

The Chairperson on behalf of the Board expressed thanks to Mr Owen Keegan for his work and contribution to the NTA Board and wished him well in his upcoming retirement.

4. CEO Report & Performance Delivery Agreement 2023

a) CEO Report

The Chief Executive outlined developments since the last meeting and responded to matters raised by Board members including the position in relation to the introduction of the electric buses on the Dublin network. It was noted that Dublin Bus had encountered a planning delay in relation to the electric charging infrastructure installation, and that appropriate steps have been taken to mitigate that delay. Route testing of the new electric buses has commenced along with driver and maintenance personnel training, with operational service to commence later this year.

b) Quarterly report on Annual Corporate Business Plan

Mr Gallagher provided a progress update on the Authority's Annual Corporate Business Plan. Following the update, Mr Gallagher responded to questions from Board members.

5. Capital Programme Committee Report

Mr Docherty provided an update report from the July meeting of the Capital Programme Committee. The following items were considered and approved by the Committee:

- Consolidated Contact Centre Contract Final Business Case;
- Project Phoenix Final Business Case
- Woodbrook Station Final Business Case; and
- ➤ Dun Laoghaire Active Travel Connector Preliminary Business Case.

Mr Docherty noted that there were a number of items considered by the Committee which are recommended for approval by the Board, which were:

- Luas Finglas Preliminary Business Case; and
- ➤ BusConnects Core Bus Corridors (Kimmage to City Centre; Ringsend to City Centre; Bray to City Centre) Approval to submit planning consent applications.

6. BusConnects Schemes Approval

a) Bray to City Centre

It was explained that in accordance with the Authority's corporate governance arrangements, Board approval is required for the submission to An Bord Pleanála of the Environmental Impact Assessment Report (EIAR), Nature Impact Statement and Compulsory Purchase Order in relation to the BusConnects Dublin Bray to City Centre Core Bus Corridor Scheme (the "**Proposed Scheme**").

It was recalled that the BusConnects Dublin Preliminary Business Case (PBC) was approved by the Board for submission to the Department of Transport (DoT) and was provided to the DoT on 4 March 2021 to facilitate Government authorisation (then required in the case of projects exceeding €100 million) in respect of Decision Gate 1 under the Public Spending Code. Government authorisation in respect of Decision Gate 1 was provided on 8 March 2022.

As that earlier Board approval was solely for the submission of the PBC to the DoT, a further Board decision is required to approve the submission of the relevant applications for approval of the Proposed Scheme under the Roads Act 1993 (as amended) and confirmation of the associated compulsory land acquisition to An Bord Pleanála.

The Chairperson noted that:

- (a) the Authority is progressing the programme known as "BusConnects Dublin";
- (b) the BusConnects Dublin programme includes twelve Core Bus Corridor Projects, including the Proposed Scheme;
- (c) in that regard, at its meeting of 18 October 2019, the Authority had resolved in accordance with section 44(2)(b) of the Dublin Transport Authority Act 2008 (as amended) ("2008 Act") in connection with the twelve Core Bus Corridor Projects including the Proposed Scheme that:
 - (i) the conditions specified in section 44(2)(b) of the 2008 Act were satisfied; and
 - (ii) the functions specified in section 44(1) of the 2008 Act should be performed by the Authority; and
- (d) among other things, in accordance with section 44(6) of the 2008 Act:
 - (i) the Authority was empowered to perform the function of securing such public transport infrastructure as a public transport authority, namely, in the case of the Proposed Scheme, a road authority; and
 - (ii) land may be acquired by agreement or by means of a compulsory purchase order made by the Authority in accordance with Part XIV of the Planning and Development Act 2000 where the Authority has made a decision under section 44(2)(b) or where the Authority is performing its function of securing the provision of public transport infrastructure in accordance with section 44(2)(e).

The Chairperson further noted that the following documents were before the Authority:

- The final draft Environmental Impact Assessment Report (EIAR) as at July 2023 which has been prepared by a team of competent experts (as described in Chapter 1 of the EIAR), for the Proposed Scheme;

7. Luas Finglas Preliminary Business Case (PBC)

Mr Creegan provided an overview of the Luas Finglas Preliminary Business Case. Mr Creegan outlined that Board approval is being sought to approve the Luas Finglas PBC under Decision Gate 1 of the Public Spending Code (PSC), conditional upon receipt of prior Government consent. Mr Creegan outlined that approval of Decision Gate 1 will allow Transport Infrastructure Ireland (TII) to proceed with submitting the Luas Finglas scheme for statutory planning consent.

Following discussion, the Board confirmed, subject to receipt of prior Government authorisation, the issue of approval in respect of Decision Gate 1 for the Luas Finglas Preliminary Business Case.

8. Procurement

a) Finance System

Mr O'Flynn provided an overview of the procurement competition related to the proposed new NTA Finance System.

Following the overview provided, and subsequent questions from the Board members, the Board approved the awarding of the contract for the Provision, Implementation, Maintenance and Support of a Financial Management Solution to Codec-dss Ltd for an initial period of three years with an option of a further three years by way of one year extensions.

b) Active Travel Support Office Services

Mr Creegan provided an overview of the procurement competition related to the Active Travel Support Officer services.

Following the overview provided, and subsequent questions from the Board members, the Board approved the awarding of the contract to Roughan O'Donovan and Clifton Scannell Emerson Associates for a fixed period of two years with the option to extend by a further two years.

Mr Seymour provided an overview of the National Cycle Design Manual and outlined that the intention was that the document will be published shortly by the NTA.

13. National Household Travel Survey

Mr Colleary provided an overview and highlighted the key points of the National Travel Household Survey 2022 results. Mr Colleary outlined that the survey will be published in the coming months.
